A vendor working on the refurbishing of EPI's new building suffered complete cardiac failure while working outside near the street in front of the building. Over the 2way radio employees heard Mark Wolschon say, "This is NOT a drill. CALL 911. We need an ambulance NOW!" The

call was made without hesitation. Within minutes, an off duty ER nurse stopped to help. About five minutes later a sheriff's deputy arrived with a defibrillator. Quick response before the ambulance arrived helped save a life! The patient is alive, well, and back at work thanks in part to hours of valuable safety training and practical practice by EPI employees.
